National Hardware Products are legitimately sold only by authorized sellers who are required to follow National's policies, procedures, and quality control standards. National reserves the right to reject warranty claims from purchasers for Products purchased from unauthorized sellers, including unauthorized Internet sites.

Finish Limited Warranty

The finish on National Hardware Products is protected by a durable topcoat designed to maintain the beauty and quality of the National Product. National warrants to the Purchaser that the finish of the Product shall be free of defects in material and workmanship from tarnishing, flaking, and discoloring from the date of purchase for as long as said Purchaser occupies the residential premises upon which the Product was originally installed ("Warranty Period"). This Finish Limited Warranty applies only to Products that were purchased from National or a National authorized seller, unless otherwise prohibited by law.
