

## NATIONAL MANUFACTURING \$250 EMAIL SIGN-UP SWEEPSTAKES OFFICIAL RULES

UPDATED October 19, 2021.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

### ELIGIBILITY

To enter participants must be 18 years or the age of majority in their state, District of Columbia(DC) or province or older at the time of entry and residents of and physically present in the United States, the DC or Canada (excluding residents of the Province of Quebec). Employees (and their immediate family members or those living in the same household) of Sponsor, National Manufacturing, a division of Spectrum Brands, Inc., and its affiliated companies, subsidiaries, divisions, parents and related companies, promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate.
